Disaster Relief General Information

Rotarians have a long and varied history of aiding victims in the wake of earthquakes, tornados, floods, wildfires, and volcanoes. Through local club and district efforts, Rotarians assist disaster victims by donating to relief funds, sending shipments of food, clothing, and medicine, collaborating with local organizations that offer emergency relief, and providing ongoing assistance during long-term reconstruction projects. These examples of humanitarianism truly demonstrate the Rotary ideal of "Service Above Self."

To provide immediate relief in the event of a disaster, Rotarians are encouraged to work with longstanding international relief agencies that are equipped to allocate money quickly and effectively to aid disaster victims. In addition, <u>RI staff</u> will publicize local club and district relief efforts via the RI Web site and the <u>Rotary News Basket</u> when informed of disaster relief initiatives and preparedness plans undertaken by individual clubs and districts.

Rotarians can utilize RI's <u>World</u> <u>Community Service program</u> to develop and support long-term relief projects in the aftermath of a disaster. Through the <u>WCS</u> Projects Exchange, they can publicize their project needs and invite other clubs and districts to join in their community service efforts.

Additionally, Rotarians can apply for funding through The Rotary Foundation's <u>Humanitarian Grants programs</u> for long-term relief projects.

How to help Iraqi war victims

To respond to Rotarians' overwhelming humanitarian interest in helping Iragi war victims, Rotary International has worked with U.S. Fund for UNICEE the and the International Committee of the Red Cross (ICRC) to set up a mechanism through which Rotarians can contribute to relief efforts in Iraq. This cooperation is aimed at addressing core issues affecting the Iragi population: water and sanitation, health and nutrition, child protection, and education.
